
Mail Survey Claim: Mailing a survey to a randomly selected number of households is the only way to ensure every resident has an equal chance of participating in the survey.

MMS Text Survey Fact: Compared to mail surveys, the number of residents invited to participate in a survey from an MMS Text invitation is significantly higher.

The overall survey responses have a margin of error of +/- 3.15% at the 95% confidence interval. Population subgroups will have a higher margin of error than the overall sample. The survey results were weighted to be representative adult population demographics for the City of Glenwood Springs.

Top Issues, Priorities, or Problems

"Please describe the top issues, priorities, or problems that you think the City of Glenwood Springs should address in the next three years." The top five themes include:

- 1. Infrastructure and Transportation: There is significant concern about road conditions, traffic congestion, and the need for infrastructure improvements such as water systems and street maintenance. Specific issues mentioned include road repairs, traffic management, pedestrian and bike accessibility, and the development of alternative transportation options.
- **2. Housing Affordability and Homelessness**: Affordable housing emerges as a pressing concern, along with issues related to rental availability, short-term rentals, and workforce housing. Additionally, there are concerns about homelessness, including the need for supportive services and strategies to address encampments and loitering.
- **3. Community Development and Planning**: Many residents express a desire for responsible growth management and thoughtful community planning. This includes considerations for preserving open spaces, enhancing parks and recreational amenities, revitalizing underutilized areas, and fostering a sense of community identity.
- **4. Environmental Conservation and Quality of Life**: There is a strong emphasis on environmental protection, sustainable practices, and maintaining Glenwood Springs' natural beauty. Residents prioritize efforts such as water conservation, reducing pollution, preserving green spaces, and addressing climate change impacts.
- **5. Community Engagement and Governance**: Concerns about city leadership, governance, and citizen engagement are prevalent. Residents seek improved communication, transparency, and accountability from local government. Additionally, there are calls for efficient use of taxpayer funds, responsible decision-making, and meaningful public involvement in decision-making processes.

Survey Best Practice #5: Engaging Hard-to-Reach Population Subgroups With a Current Voter File & MMS Text Messages

- ➤ It is rich with resident information including, age, residential address and geographic data.
- > We can geocode the file and append American Community Survey census data.
- ➤ This improves our ability to concentrate MMS Text survey invitations toward hard-to-reach populations including low-income households and populations of color in real time.
- ➤ A USPS residential databases does not have up-to-date resident information. Voter files do!





Generally speaking, do you approve or disapprove of the job the City of Westminster is doing managing city services, programs, and initiatives?






How familiar are you with the Westminster Fire Department and the services they provide?



Do you think fire risk in Westminster has increased, stayed about the same, or declined in the past five years?








Uninformed 8-Mill Property Tax Ballot Test



Uninformed 0.50% Sales Tax Increase

One ballot measure being considered is a 0.5% sales tax increase that would generate about \$17.2 million annually. In addition, one-half of the 0.5% sales tax would "sunset" and expire after 20 years once the fire station facilities are paid off.







Why 49% of Respondents Oppose an 8-Mill Property Tax Increase

Property Taxes Already Too High

Many respondents express concern that property taxes are already too high and have increased substantially in recent years. They feel burdened by these increases, especially those on fixed incomes, and believe they cannot afford any further hikes.

Preference for Sales Tax





Fairness

Many respondents believe that a sales tax increase is fairer than a property tax increase, as it spreads the financial burden across a wider population, including visitors and shoppers in Westminster. They feel that everyone who benefits from the fire department's services should contribute, not just homeowners.

Safety and Service

There is a strong consensus that supporting the fire department is crucial for public safety. Respondents emphasize the importance of having well-equipped firefighters, modernized facilities, and efficient emergency response services to keep the community safe, especially in the face of increasing risks such as wildfires and population growth.

Financial Impact and Affordability

Some respondents mentioned that the proposed sales tax increase would have a minimal financial impact compared to a property tax increase, which is already perceived as high. They expressed concerns about the affordability of property taxes, especially for those on fixed incomes, and viewed the sales tax as a more manageable option.





SHALL OURAY COUNTY'S TAXES BE INCREASED BY \$411,003 BEGINNING JANUARY 1, 2022 AND ANNUALLY THEREAFTER IN SUCH AMOUNTS AS ARE RECEIVED EACH YEAR FROM THE IMPOSITION OF AN ADDITIONAL TWO (2) MILLS LEVIED UPON THE TAXABLE REAL AND PERSONAL PROPERTY WITHIN THE COUNTY (\$14.30/year of property taxes per \$100,000 value of residential property); THE REVENUES FROM WHICH SHALL BE DEPOSITED IN THE PUBLIC HEALTH FUND AND USED SOLELY FOR THE OPERATION, MAINTENANCE, AND CAPITAL EXPENSES OF OURAY COUNTY PUBLIC HEALTH SERVICES; AND SHALL THE LEVY AND THE FULL AMOUNT OF ANY EARNINGS THEREON BE COLLECTED, RETAINED, AND EXPENDED AS A VOTER APPROVED REVENUE CHANGE WITHOUT LIMITATION OR CONDITION UNDER ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION AND COLORADO REVISED STATUTES SECTION 29-1-301 ET SEQ OR ANY OTHER LAW, ALL IN CONFORMANCE WITH OURAY COUNTY RESOLUTION 2021-030?
